### WEBSITE TERMS OF USE

Welcome to the Beyond Ascent website (the "Website"), operated by Beyond Ascent Limited ("we," "us," or "our"), a UK-based provider of Special Educational Needs (SEN) tutoring services. These Terms of Use ("Terms") govern your access to and use of the Website, including all content, services, and products available on or through the Website. By accessing or using the Website, you agree to be bound by these Terms.

Please read these Terms and Conditions carefully and ensure that you understand them. Your agreement to comply with and be bound by these Terms is deemed to occur upon your first use of Our Site. If you do not agree to comply with and be bound by these Terms and Conditions, you must stop using Our Site immediately.

## 1. Acceptance of Terms

By using the Website, you confirm that you are at least 18 years of age or have the legal capacity to enter into these Terms under the laws of England and Wales. If you are using the Website on behalf of an organisation or as a parent/guardian arranging tutoring services for a minor, you represent that you have the authority to bind that organisation or act on behalf of the minor. These Terms apply to all users, including parents, guardians, students, or other visitors to the Website.

## 2. Changes to Terms

We reserve the right to modify or update these Terms at any time at our sole discretion. Changes will be effective immediately upon posting the updated Terms on the Website, and we will update the "Last Updated" date. Your continued use of the Website after any changes constitutes your acceptance of the revised Terms. We recommend reviewing these Terms periodically.

#### 3. Access to Our Site

- Access to Our Site is free of charge.
- It is your responsibility to make any and all arrangements necessary in order to access Our Site.
- Access to Our Site is provided "as is" and on an "as available" basis. We may alter, suspend or discontinue Our Site (or any part of it) at any time and without notice. We will not be liable to you in any way if Our Site (or any part of it) is unavailable at any time and for any period.

Subject to your compliance with these Terms, we grant you a limited, non-exclusive, non-transferable, and revocable licence to access and use the Website for personal, non-commercial purposes, such as exploring our services or managing bookings. You may not reproduce, distribute, modify, or create derivative works from any content on the Website without our prior written consent, except as permitted for educational purposes in connection with our tutoring services.

#### 5. Use of the Website

### 5.1 Permitted Use

You may use the Website only for lawful purposes and in accordance with these Terms. The Website is intended to provide information about our SEN tutoring services, facilitate bookings, and support communication with our team. You agree not to:

- Use the Website in any way that violates any applicable laws or regulations in the United Kingdom, including the Equality Act 2010 and Data Protection Act 2018.
- Engage in any conduct that restricts or inhibits anyone's use or enjoyment of the Website or that may harm Beyond Ascent or its users.
- Use any automated systems, such as robots or spiders, to access the Website for any purpose, including copying or monitoring content, without our prior written consent.
- Attempt to gain unauthorised access to, interfere with, damage, or disrupt any part of the Website, its servers, or any connected systems.

## 5.2 Account Registration

Some features of the Website, such as booking tutoring sessions or accessing resources, may require you to create an account. You agree to:

- Provide accurate, current, and complete information during registration.
- Keep your account information updated.
- Maintain the confidentiality of your account credentials and accept responsibility for all activities under your account.
- Notify us immediately of any unauthorised access to or use of your account.

## 6. Tutoring Services



# 6.1 Service Description

Beyond Ascent provides SEN tutoring services, including one-to-one and group sessions tailored to the needs of students. Details of our services and availability, are provided on the Website or upon request. All services are subject to availability and our separate service agreements or booking terms, which will be provided at the time of booking.

# 6.2 Booking and Payment

Bookings for tutoring sessions are made through the Website or by contacting us directly. Payment terms, cancellation policies, and refund policies will be outlined in our booking confirmation or service agreement. We reserve the right to refuse or cancel bookings at our discretion, subject to applicable consumer protection laws.

### 7. User Content

#### 7.1 Submission of Content

The Website may allow you to submit content, such as feedback, reviews, or communications related to tutoring services ("User Content"). By submitting User Content, you grant Beyond Ascent a worldwide, non-exclusive, royalty-free, perpetual, and sublicensable right to use, reproduce, adapt, and display such User Content for purposes related to our services, including marketing and improving our offerings.

## 7.2 Responsibility for User Content

You are solely responsible for any User Content you submit. You represent that your User Content:

- Does not infringe any third-party rights, including intellectual property or privacy rights.
- Is not unlawful, defamatory, offensive, or otherwise objectionable. We reserve the right to remove or disable access to any User Content that violates these Terms or our policies.

# 8. Privacy and Data Protection

Your use of the Website is governed by our Privacy Policy. As a UK-based business, We comply with the Data Protection Act 2018 and UK GDPR regarding the collection, use, and storage of personal data, including sensitive information related to SEN students. By using the Website, you consent to the processing of your personal data as described in our Privacy Policy.

The Website may include links to third-party websites or services (e.g., payment processors or educational resources). We are not responsible for the content, privacy policies, or



practices of these third-party websites. You access such websites at your own risk and should review their terms and policies.

## 10. Viruses, Malware and Security

- 10.1 We exercise all reasonable skill and care to ensure that Our Site is secure and free from viruses and other malware.
- 10.2You are responsible for protecting your hardware, software, data and other material from viruses, malware, and other internet security risks.
- 10.3You must not deliberately introduce viruses or other malware, or any other material which is malicious or technologically harmful either to or via Our Site.
- 10.4You must not attempt to gain unauthorised access to any part of Our Site, the server on which Our Site is stored, or any other server, computer, or database connected to Our Site.
- 10.5You must not attack Our Site by means of a denial-of-service attack, a distributed denial of service attack, or by any other means.
- 10.6By breaching these Terms, you may be committing a criminal offence under the Computer Misuse Act 1990. Any and all such breaches will be reported to the relevant law enforcement authorities and We will cooperate fully with those authorities by disclosing your identity to them. Your right to use Our Site will cease immediately in the event of such a breach.

(including reasonable legal fees) arising from your use of the Website, violation of these Terms, or infringement of any third-party rights.

#### 13. Termination

We may suspend or terminate your access to the Website at our discretion, without prior notice, if you breach these Terms or for any other lawful reason. Upon termination, your right to use the Website will cease immediately. Termination does not affect any obligations related to tutoring services already booked, which are governed by our service agreements.

### 14. Governing Law and Dispute Resolution

These Terms are governed by and construed in accordance with the laws of England and Wales. Any disputes arising under or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of England and Wales, except where alternative dispute resolution is required under UK consumer law.

## 15. Consumer Rights

Nothing in these Terms affects your statutory rights as a consumer under the Consumer Rights Act 2015 or other applicable UK legislation. If you are a consumer, you may have additional rights, including the right to cancel certain services within 14 days under the Consumer Contracts Regulations 2013.
